#### The expected benefits of the research

It is expected that this project will not directly benefit the participants; however, your involvement will provide valuable information that may expand our current understanding of social media use, parenting and wellbeing as well as inform future research and parenting initiatives.

#### Risks to you

There are no foreseeable risks associated with participation in this study. ## Your confidentiality

Your personal responses will remain confidential and none of your information will be publicly identifiable. You will be asked to take part in two online surveys with the second survey being completed in early-mid 2026. Responses to the on-line survey will form part of a large data response set, which will be stored securely via an encrypted file on a password protected Sharepoint file that only project researchers will have access to. All data submitted online will be protected by firewall systems and secure methods, in compliance with legislation.

The researchers are conducting this survey in partnership with NORC Research Centre. NORC is a non-profit social research organisation based at the University of Chicago. NORC will not store copies of the information you provide in the survey. Any information that you provide will not be used by NORC or any commercial third parties. NORC have no commercial interest in the data collected.

Although some identifiable information will be collected by the research team (token to enter the survey which will be attached to your mobile number), this information will be stored separately from responses. This information will also be stored securely and will be destroyed at the end of the study. This information will not be shared in any way.

The dataset may be kept for up to seven years, in accordance with Australian guidelines and Journal publication guidelines. All participant information will be aggregated in any future publications.

## Your participation is voluntary

Your participation is voluntary and you are free to withdraw without reason, up until you submit your survey response. If you withdraw from the study your data will not be used and it will be destroyed. To withdraw from the study, you will need to close out the survey before submitting it. All submitted survey responses cannot be identified and therefore cannot be deleted once they have been submitted.

De-identified study data will be made available publicly via the Open Science Framework (you will never be identified in this data). Providing the date to the Open Science Framework will allow other research teams to re-use the data and assist in furthering our understanding of digital parenting.
